LICENSED STUDENTS RECRUITMENT AGENCIES

Introduction

Licensing of Student Recruitment Agencies is one of the functions of the Commission for University Education (CUE) provided in The Universities Act No. 42 of 2012; The Universities Regulations, 2014; Sections 71-75 and The Universities Standards and Guidelines, 2014. It ensures that local agencies recruiting students for foreign universities are duly regulated for the benefit of Kenyans intending to pursue university education in accredited and recognized institutions; and awarded degrees outside Kenya. This makes CUE to know valid Student Recruitment Agencies operating in Kenya and track and keep data of the number of students studying in accredited foreign universities; and the validity of certificates acquired. Licensing of Student Recruitment Agencies as one of the functions of CUE aims at:

- a) Streamlining the local agencies for student recruitment into foreign universities;
- b) Regulating the agencies for advertising, exhibiting and marketing foreign universities in Kenya.
- c) Regulating foreign universities directly advertising, exhibiting or recruiting students in Kenya.
- d) Ensuring that Kenyan students are recruited and admitted to study in accredited and recognized universities outside the country, and be awarded with valid and recognized certificates.
- e) Taking appropriate action against Student Recruitment Agencies operating illegally in Kenya
